Organic Garage Announces Issuance of Shares

December 30, 2016, Toronto, Canada: Organic Garage Ltd. ("Organic Garage") (CSE:OG) announces that it has issued in aggregate 300,000 common shares (the "Shares") to directors, officers and consultants in settlement of fees in lieu of cash of \$90,000, subject to board approval regarding resale for 12 months.

The issuance of the Shares constitutes a related party transaction pursuant to Multilateral Instrument 61-101 - Protection of Minority Security Holders in Special Transactions ("MI 61-101"). Organic Garage is exempt from the formal valuation and minority approval requirements of MI 61-101 in reliance on Sections 5.5(a) and (b) and Sections 5.7(a) and (b), respectively, of M1 61-101. The Shares were issued under an exemption from prospectus exemptions under National Instrument 45-106 ("NI 45-106"). All securities will also be subject to the standard four month hold under NI 45-106.
